## REMINDER: ID CARD CHANGES COMING

As of June 1, Social Security numbers are no longer printed on new ID cards issued to members of the Uniformed Services, retirees and family members. The new cards will have a unique DoD Identification number in place of the Social Security number. For those eligible for benefits, such as health care, a DOD benefits number will be on the back. Beneficiaries using the Military Health System and TRICARE should be prepared to state their Social Security number (or their sponsor's) when accessing health care or pharmacy benefits. ## CONTRACT FIGHT BETWEEN WALGREENS AND EXPRESS SCRIPTS REACHES IMPASSE

Express Scripts, which is the contractor for both the TRICARE Retail Pharmacy and TRICARE Pharmacy Home Delivery, and Walgreens, the largest drug store chain in the country, is having a knocked down drag out contract fight. This week Walgreens publically announced that they would stop filling Express Scripts prescription benefits on January 1, of course, there are still many months to go. Walgreens receives over \$5.5 billion in annual revenue from Express Scripts plans; it makes a full 7% of their revenue. (Express Scripts is the second-largest pharmacy benefits manager in the United States and expects to handle at least 750 million prescription claims this year.) Surely, we will hear more about this in the weeks ahead; TREA will watch to see if this fight may harm TRICARE Pharmacy beneficiaries and keep you informed.

## 2011 COLA FOR RETIRED PAY

The current inflation rate of 3.4 percent may mean an increase in military retirement pay, compensation and pension for disabled veterans and social security recipients in 2012.

Each year Military Retirement pay, VA Compensation and Pensions, and Social Security benefits are adjusted for the rate of inflation. This annual Cost of Living Adjustment is determined by the [Consumer Price Index](#) for the previous year. In a normal cycle, the CPI for a given year is compared to the previous year to determine the actual rate of inflation. However, since 2008 was the last year the rate of inflation was positive, it is the baseline for determining the 2010 rate of inflation.

## THE WORST STATES IN THE U.S. FOR VETERAN EMPLOYMENT

As you all know while the job market has been bad for everyone, it has been dramatically worse for veterans, especially veterans of the wars in Iraq and Afghanistan. There are many theories as to why this is true, we do not know for sure- but we now definitely know where in the country employment is worse for them. Below are the 10 worst state for 9/11 unemployment. Following the veterans unemployment percentages are the overall unemployment rates in those states compiled by the Bureau of Labor. These figures come from the U.S. Congress Joint Economic Committee.
